WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0210-A series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by PROVINCIAL BUDGET MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2022-0031 re; Procurement of Pedestal Fill Drawer, Uninterruptible Power Supply & Heavy Duty Laminator, by the Provincial Budget Management Office, New Capitol Compound, Tagbilaran City, Bohol. with an ABC of ₱ 20,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




