WHEREAS, the EDUCATION DEVELOPMENT CENTER (EDCENTER), of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0036 re; Procurement of Computer Desktop with Printer, by the Education Development Center (EDCenter), Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 70,000.00;
