BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>CENTER FOR CULTURE & ARTS DEVELOPMENT</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0245</u>, re; <u>Procurement of IT Equipment</u>, by the <u>Center for Culture & Arts Development</u>, <u>Bohol Provincial Capitol Building</u>, <u>Cogon District</u>, <u>Tagbilaran City</u>, with an ABC of <u>P 100,329.50</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation <u>B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED:

- a.) To declare <u>B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.</u> as the supplier with the **LOWEST** CALCULATED AND RESPONSIVE QUOTATION, for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2022-0167;
- b.) To recommend award to <u>B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.</u> for the delivery of goods/services under Negotiated Canvass No. <u>2022-0167</u> in the amount of <u>P 99,880.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
