BAC Resolution Recommending the Use of Alternative Mode of through Direct Contracting, Declaring Single Calculated and Responsive Bid and Recommending Approval

WHEREAS, the <u>Chief of the TEODORO B. GALAGAR DISTRICT HOSPITAL</u>, <u>JAGNA, BOHOL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. <u>- PHO - 2022 - 125</u> re: <u>PROCUREMENT OF MEDICAL OXYGEN</u> with an ABC of P747,500.00;
