BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>BOHOL DISTRICT JAIL</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0214</u> re; <u>Procurement of Fuel (Diesel & Unleaded)</u>, by the Bohol District Jail, <u>Cabawan District</u>, <u>Tagbilaran City</u>, <u>Bohol</u>. with an ABC of <u>P 138,950.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>HI-WAY GAS STATION</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of HI-WAY GAS STATION including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation HI-WAY GAS STATION has been found to be ELIGIBLE and its bid, RESPONSIVE;
