BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **BOHOL DISTRICT JAIL**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0214 re; Procurement of Fuel (Diesel & Unleaded), by the Bohol District Jail, Cabawan District, Tagbilaran City, Bohol. with an ABC of P 138,950.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **HI-WAY GAS STATION** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **HI-WAY GAS STATION** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **HI-WAY GAS STATION** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;
