BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the BOHOL MINERAL RESOURCE REGULATORY OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0147, re; Procurement of Various Office Supplies, by the Office of the Bohol Mineral Resources Regulatory Office, New Capitol Compound, Tagbilaran City, with an ABC of P 110,588.80;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 5 ANGELS TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of 5 ANGELS TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation 5 ANGELS TRADING, has been found to be ELIGIBLE and its bid, RESPONSIVE;

- b.) To recommend award to 5 ANGELS TRADING for the delivery of goods/services under Negotiated Canvass No. 2022-0086 in the amount of P 75,588.80 except item no. 12;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
