WHEREAS, the BOHOL ENVIRONMENT MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0821 re; Procurement of Supplies for Removal of Phosphorous & Nitrate in Raw Wastewater, by the Bohol Environment Management Office, New Capitol Building, New Capitol Site, Tagbilaran City, Bohol. with an ABC of P 110,500.00;


