WHEREAS, the PROVINCIAL BUDGET & MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2022-0023, re: Procurement of Office Supplies - Toner Kyocera TK-6113 & Maintenance Kit - 6119 for ECOSYS M4125IDN, by the Provincial Budget & Management Office, New Capitol Compound, Tagbilaran City, Bohol, with an ABC of P 61,600.00;
