**WHEREAS**, the **CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. **2022 – 182 re: Procurement of various MEDICINES** with an ABC of **P624,705.00;**

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DEXTEL TRADING** offered the Single price quotation as reflected in the Abstract of Bid Quotations,
