GALAGAR DISTRICT HOSPITAL</u>, <u>JAGNA, BOHOL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. <u>PHO – 2022 – 062</u> re: <u>PROVISION OF ANNUAL PREVENTIVE MAINTENANCE PACKAGE OF PHILIPS FULL DIGITAL X-RAY MACHINE (FULL COMPREHENSIVE) PROTECTION PACKAGE</u> with an ABC of <u>P 850,000.00</u>;
