WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u>, <u>NEW CAPITOL BUILDING</u>, <u>COGON DISTRICT</u>, <u>TAGBILARAN CITY</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. <u>2022 - - 140</u> re: <u>PROCUREMENT OF DIESOLINE</u> with an ABC of <u>P 1,792,472.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL JL DISTRIBUTION</u> <u>SYSTEM INC.</u> offered the Single price quotation as reflected in the Abstract of Bid Quotations,
