BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 22-0502 Series of 2022

WHEREAS, the <u>PROVINCIAL MOTOR POOL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0296</u> re; <u>Procurement of Office Supplies</u>, <u>by the Provincial Motor Pool</u>, <u>New Capitol Compound</u>, <u>Tagbilaran City</u>, with an ABC of <u>P 71,539.50</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BLUE ARROW SIGNS & PRINTS</u>, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BLUE ARROW SIGNS & PRINTS, INC.</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation <u>BLUE ARROW SIGNS & PRINTS, INC.</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
