WHEREAS, the **OFFICE OF BOARD MEMBER LUCILLE YAP LAGUNAY**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0298 re; Procurement of Various Spare Parts for SKY 389, by the Office of Board Member Lucille Yap Lagunay, New Capitol Compound, Tagbilaran City. with an ABC of P 54,680.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
