**WHEREAS**, the **OFFICE OF THE GOVERNOR**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2022-0405**, re; **Procurement of Alcohol & Disinfectant Concentrate, by the Office of the Governor, New Capitol Compound, Tagbilaran City**, with an ABC of **P 299,950.00**;




**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




