WHEREAS, the **BOHOL DISTRICT JAIL**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0229, re; Procurement of Drugs & Medicines, by the Bohol District Jail, Cabawan District, Tagbilaran City, Bohol, with an ABC of P 71,414.80;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BYRO PHARMA CORPORATION** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




