WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0142, re; Procurement of Cellophane Bag, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P 82,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LEZAR TRADING. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
