CARLOS P. GARCIA MUNICIPAL HOSPITAL, PRES. GARCIA BOHOL** in undertaking Procurement Request under **PR No. – PHO – 2022 – 072** re: **PROCUREMENT OF MEGA BOX STORAGE, ORBIT FAN, REFRIGERATOR, GROCERY SHOPPING CART, STEEL BENCH & CCTV SECURITY SYSTEM** with an ABC of **P 350,000.00**;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




