



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2022 - 080** re: **PROCUREMENT OF BP APPARATUS, AMLODIPINE, LOSARTAN & METFORMIN** with an ABC of **P 224,999.45**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BYRO PHARMA CORPORATION** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b.) To recommend award to **BYRO PHARMA CORPORATION** in the amount of **TWO HUNDRED TWENTY TWO THOUSAND FIVE HUNDRED FIFTY SEVEN PESOS AND 45/100 (P 222,557.45)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2022 - 030**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


