WHEREAS, the **BOHOL INFORMATION, COMMUNICATION AND TECHNOLOGY OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-122** re: **PROVISION OF VENUE WITH ACCOMMODATION, MEALS AND SNACKS FOR THE BICTO MID-YEAR ASSESSMENT** with an ABC of **₱ 120, 000.00**;
