BAC RESOLUTION DECLARING SCRQ THROUGH NEGOTIATED MODE OF PAYMENT – EMERGENCY CASES AND RECOMMENDING AWARD

WHEREAS, the CANDIJAY COMMUNITY HOSPITAL, CANDIJAY, BOHOL of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **PHO – 2022 – 210 re: Procurement of Covid-19 Ag Rapid Test Device, Gram Stain Solution & Dengue Duo with an ABC of ₱ 379,400.00;**




