**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0315-A series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **PROVINCIAL MOTOR POOL OFFICE** in undertaking Procurement Request under PR No. 2022-0174 re; Procurement of Tires, by the Provincial Motor Pool, New Capitol Compound, Tagbilaran City, with an ABC of **₱ 513,750.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;




**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**:






