WHEREAS, the **PROVINCIAL ASSESSOR'S OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022-0327** re; **Procurement of Offices Supplies, by the Provincial Assessor's Office, New Capitol Compound, Tagbilaran City**, with an ABC of **P 54,186.56**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




