WHEREAS, the **PROVINCIAL ACCOUNTING OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0362 re; Procurement of Various Offices Supplies, AAA & AA Batteries and Heavy Duty Automatic Numbering Machine, by the Provincial Accounting Office, New Capitol Compound, Tagbilaran City. with an ABC of P 87,622.50;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:






