WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0483 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **GOVERNOR'S OFFICE-BOHOL INFORMATION AND COMMUNICATION TECHNOLOGY OFFICE** in undertaking Procurement Request under PR No. 2021-0244 re: Procurement of Plastic Desk File Organizer, 4 Layer Drawers Vertical Steel Filing Cabinet & Steel Mobile Filing Pedestal, by the Governor's Office-Bohol Information and Communication Technology Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol, with an ABC of **₱ 135,300.00;**


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **3 MSG ENTERPRISES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
