BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL AGRICULTURIST'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-320** re: **PROCUREMENT OF FULLBOARD & CATERING SERVICES DURING THE NUTRITION PROGRAM IMPLEMENTATION REVIEW** with an ABC of **₱ 93,500.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BEST WESTERN PLUS THE IVYWALL RESORT - PANGLAO** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;


