BAC Resolution Recommending Procurement thru Negotiated Mode *Resulting from the Second Phase of Bidding* Declaring Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the **OFFICE OF THE PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-215** re: **PROCUREMENT OF CATERING AND ACCOMMODATION SERVICES FOR THE OFFICE MID-YEAR ASSESSMENT AND PLANNING WORKSHOP** with an ABC of **₱132,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that **PANGLAO BLUEWATER BEACH RESORT, INC.** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
