BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0815 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL VETERINARIAN, NEW CAPITOL BUILDING, TAGBILARAN CITY in undertaking Procurement Request under PR No. 2022-0384 re: Procurement of Stainless Tables and Racks for distribution to identified meat processor in support of Meat Enterprise Program with an ABC of P 520,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3 MSG ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, 3 MSG ENTERPRISES has been found to be ELIGIBLE and its quotation, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare 3 MSG ENTERPRISES as the supplier with the **Lowest Calculated and Responsive Price Quotation** for the Delivery of **Goods/Services** under Negotiated Canvass No. 2022-0395 (2ND Failure);
- b). To recommend award to 3 MSG ENTERPRISES or delivery of goods/services under Negotiated Canvass No. 2022-0395 (2nd Failure) in the amount of P 519,840.00;
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
