BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF THROUGH DIRECT CONTRACTING, DECLARING SOLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL ADMINISTRATOR'S OFFICE-PPMU** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of the goods under Purchase Request No. 2022-0572, re: Procurement of Toner for Gestetner Photocopying Machine, by the Provincial Administrator's Office-PPMU, New Capitol Compound, Tagbilaran City, Bohol. with an ABC of P 7,770.00;


