WHEREAS, the PROVINCIAL ACCOUNTING OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-157 re: PROCUREMENT OF MEALS AND SNACKS FOR THE CONDUCT OF THE ANNUAL CONSULTATIVE FORA ON FISCAL MATTERS PARTICULARLY FOR THOSE PGBH PERSONNEL SUCH AS ADMINISTRATIVE OFFICERS, PAYROLL MAKERS (JOS), FUND CUSTODIANS AND DESIGNATE PERSONNEL IN-CHARGE IN THE PREPARATION OF DVS, PAYROLLS AND PRS with an ABC of P 99, 750.00;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:




