WHEREAS, the **OFFICE OF THE GOVERNOR, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2022 – 0589** re: **Purchase of Tires, Battery, Oil and Lubricants** for the service vehicle used at Governor's Office with plate no. **SJC – 371** Isuzu crosswind with an ABC of **P92,137.00**;






NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:






