BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL PLANNING & DEVELOPMENT OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0507, re; **Procurement TIRES AND BATTERY**, by the Provincial Planning & Development Office **New Capitol Building, Cogon District, Tagbilaran City**, with an ABC of P 84,125.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **NORTHWAY TYRE CENTRE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:






