WHEREAS, the PROVINCIAL HEALTH/OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-148 re: PROCUREMENT OF CATERING SERVICES FOR THE NATIONAL LEPROSY CONTROL PROGRAM with an ABC of ₱ 189, 550.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA GARDEN SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
