WHEREAS, the <u>BOHOL PROVINCIAL ENVIRONMENT MANAGMENT OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under <u>Purchase Request No. 2022-C-199 re: <u>PROVISION OF MEALS AND SNACKS TO SUPPORT GEOPARK – RELATED ACTIVITIES IN PARTNERSHIP WITH LAUM-BOHOL/ PYDO</u> with an ABC of <u>P 131,200.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>REYNA'S THE HAVEN</u>
<u>AND GARDENS FOOD CATERING SERVICES, INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

- b). To recommend award to <u>REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.</u> for the Catering and Accommodation Services of the aforementioned request in the amount of <u>P 130, 560.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
