WHEREAS, the **BOHOL PROVINCIAL ENVIRONMENT MANAGEMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-199** re: **PROVISION OF MEALS AND SNACKS TO SUPPORT GEOPARK – RELATED ACTIVITIES IN PARTNERSHIP WITH LAUM-BOHOL/ PYDO** with an ABC of **₱ 131,200.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
