**BAC Resolution Declaring LCRQ and Recommending Award**

**WHEREAS**, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-363 re: PROCUREMENT OF CATERING SERVICES FOR THE OPA EMPLOYEES DURING THE FAMILY DAY 2022 with an ABC of ₱ 71,250.00;
