BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **CANDIJAY COMMUNITY HOSPITAL, CANDIJAY, BOHOL** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO – 2022 – 232 re: **PROCUREMENT OF DUPLICATING MACHINE** with an ABC of **P 175,000.00**.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PHILIPPINE DUPLICATORS, INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **PHILIPPINE DUPLICATORS, INC** and **COPYLANDIA OFFICE SYSTEMS CORP.** including the price quotation offered and Technical Specifications, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, **COPYLANDIA OFFICE SYSTEMS CORP.** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**, as per recommendation by TWG (see attached copy with result to post qualification process).
