WHEREAS, the OFFICE OF THE GOVERNOR – CENTER FOR CULTURE AND ARTS DEVELOPMENT, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022 – 0761 re: Procurement of various painting, construction and electrical supplies for the restoration and re-installation of Giant Belen for Kasadya! Pasko sa Bohol with an ABC of P 370,609.70;





NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


