WHEREAS, the Bids and Awards Committee (BAC) under the previous administration prepared the attached Resolution Declaring Lowest Complying and Responsive Bid and Recommending Approval of Award to the highest bidder for the Philippine Rural Development Project (PRDP) subproject: REHABILITATION OF PONDOL TO CANDAIGAN FARM TO MARKET ROAD, Loon, Bohol under project reference number PRDP-IB-R007-BOH-007-000-000-2014-AF2 with Estimated Project Cost of PhP114,041,000.00;

WHEREAS, upon the conduct of post-qualification evaluation of the lowest evaluated bid, BSP and Company Inc., it was found out that its bid met the qualification requirements of the bidding documents


NOW THEREFORE, We the Members of the Bids and Awards Committee, her by RESOLVE, as it is hereby RESOLVED:
