



Thank you for your attached letter dated November 14, 2022 (received on November 18) regarding the above subject procurement. We appreciate the continuous effort of the Project under your leadership to resolve the matter, and move forward. We note of your endorsement of the procurement-related documents for the two subprojects. We reviewed the Bid Evaluation Report (BER) and other relevant documents for each of the subprojects, and based on the information provided, with Bank Procurement Regulations principles taken into consideration, we have no objection to the proposed award of contracts, as follows:

1. BSP and Company Inc., as the LOWEST CALCULATED and RESPONSIVE BID (also the lowest bidder) for the REHABILITATION OF PONDOL TO CANDAIGAN FARM-TO-MARKET ROAD, Loon, Bohol in the amount not to exceed PhP91,448,601.20; and
2. BSP and Company Inc., as the LOWEST CALCULATED and RESPONSIVE BID (also the lowest bidder) for the REHABILITATION OF CAMPAGAO TO CABACNITAN FARM-TO-MARKET ROAD, Bilar, Bohol in the amount not to exceed PhP170,521,136.70.

We note further that both proposed awards are below the respective estimated project costs (EPC), and corrected the previous BERs proposing to award to the highest bidder for the respective subprojects. We commend the procurement unit of the various levels (RPCO, PSO & NPCO) for their joint review, as we encourage everyone to act quickly (within the updated bid validity period of November 30, 2022) moving forward to take advantage of this opportunity to optimize the value for money proposition of the situation, and to avoid any further delays in the implementation of these long overdue subprojects.
