WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. PRDP-GEF-MPA-006 re: SUPPLY AND DELIVERY OF BOATS for the following Marine Protected Areas (MPA) of the Office of the Provincial Agriculturist Fisheries Division with and ABC of Php 4,708,663.13;
