WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. PROP-GEF-MPA-008 re: FUEL DEPOSITS for the following Marine Protected Areas (MPA) of the Office of the Provincial Agriculturist Fisheries Division with and ABC of Php 190,633.21;

WHEREAS, canvass of prices done in the course of the Shopping Method of Procurement showed that <u>PETROGAZ</u> <u>REFILLING STATION</u> offered the lowest calculated and responsive quotation among the suppliers as reflected in the Abstract of Bids Quotations.

WHEREAS, pursuant to Section 52.1 of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>PETROGAZ REFILLING STATION</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation, <u>PETORGAZ REFILLING STATION</u> has been found to be <u>ELIGIBLE</u> and its quotation, <u>RESPONSIVE</u>;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>PETROGAZ REFILLING STATION</u> as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Shopping Canvass No. <u>9097634</u>;
- b.) To recommend award to <u>PETROGAZ REFILLING STATION</u> for the delivery of goods/services the aforementioned request in the amount of <u>Php 186,303.46</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
