WHEREAS, the **OFFICE OF THE PROVINCIAL AGRICULTURIST** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **PRDP-GEF-MPA-008** re: **FUEL DEPOSITS** for the following Marine Protected Areas (MPA) of the Office of the Provincial Agriculturist Fisheries Division with and ABC of **Php 190,633.21**;

WHEREAS, canvass of prices done in the course of the Shopping Method of Procurement showed that **PETROGAZ REFILLING STATION** offered the lowest calculated and responsive quotation among the suppliers as reflected in the Abstract of Bids Quotations.
