WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. PRDP-GEF-MPA-009 and PRDP-GEF-MPA-0010 re: PROCUREMENT OF MPA SUPPLIES AND MATERIALS for the following Marine Protected Areas (MPA) of the Office of the Provincial Agriculturist Fisheries Division with and ABC of Php 900,644.26;

WHEREAS, canvass of prices done in the course of the Shopping Method of Procurement showed that <u>JR and KD PRINCE</u> <u>ENTERPRISES</u> offered the lowest calculated and responsive quotation among the suppliers as reflected in the Abstract of Bids Quotations.

WHEREAS, pursuant to Section 52.1 of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>JR and KD PRINCE ENTERPRISES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation, <u>JR and KD PRINCE ENTERPRISES</u> has been found to be <u>ELIGIBLE</u> and its quotation, <u>RESPONSIVE</u>;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED:

- a.) To declare <u>JR and KD PRINCE ENTERPRISES</u> as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Shopping Canvass No. <u>9097642</u>;
- b.) To recommend award to <u>JR and NO PRINCE ENTERPRISES</u> for the delivery of goods/services the aforementioned request in the amount of <u>Php 900,300.00</u>;
