**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the **BOHOL INFORMATION AND COMMUNICATION TECHNOLOGY OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022 – 0645** re; **Procurement of VPS Server Account** with an ABC of **P 250,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **B & J COMPUTER SALES AND ELECTRONIC SERVICES, INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **B & J COMPUTER SALES AND ELECTRONIC SERVICES, INC.**, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **B & J COMPUTER SALES AND ELECTRONIC SERVICES, INC.** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;
