BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF PROCUREMENT THROUGH DIRECT CONTRACTING, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **OFFICE OF THE PROVINCIAL AGRICULTURIST, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of the goods under Purchase Request No. **2022-0736** re: Procurement of various spare parts for the replacement of unserviceable parts for Ineo 283 photocopier machine under property no. 18x90 with an ABC of **P 56,124.00**;
