**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE,
 DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL SITE COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 438 re: PROCUREMENT OF OFFICE SUPPLIES with an ABC of P 98,900.00

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BAYONG'S CONSUMER GOODS TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings




