## RESOLUTION NO. W WAZ Series of 2022

BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE. DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL SITE COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 438 re: PROCUREMENT OF OFFICE SUPPLIES with an ABC of P 98,900.00

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BAYONG'S CONSUMER GOODS TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals.

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BAYONG'S CONSUMER GOODS TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid BAYONG'S CONSUMER GOODS TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED:

- To declare BAYONG'S CONSUMER GOODS TRADING as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2022 - 255.
