WHEREAS, upon the conduct of post qualification by the Technical Working Group, **PARK AVENUE GENERAL MERCHANDISE, GOLDEN AI TRADING, BOHOL QUALITY CORP., PRIM E CONSTRUCTION SUPPLIES TRADING** met the required legal, technical and financial requirements for the said project;
