WHEREAS, the **OFFICE OF THE PROVINCIAL AGRICULTURIST** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **PRDP-MPA-R007-BOH-008-UBA-001-2015** re: **SUPPLY OF LABOR AND MATERIALS FOR THE REPAIR, REHAB AND RESTORATION OF GUARDHOUSE** for the following Marine Protected Areas (MPA) of the Office of the Provincial Agriculturist Fisheries Division with and EPC of **Php.650,465.00**;
